DEFENDANT'S REQUEST FOR A DRIVING SAFETY COURSE

I hereby enter my appearance on the complaint of the offense of: \_\_\_\_\_ in person, by counsel, by fax, by regular mail, or by email. I understand that I have a right to a jury trial. I hereby waive my right to a jury trial, plead:

( ) GUILTY or

( ) NOLO CONTENDER "NO CONTEST"

and elect under Article 45.0511, Code of Criminal Procedure, to take a driving safety course. I have not completed a driver safety course/defensive driving course within the last 12 months for a ticket dismissal.

----I UNDERSTAND THAT I MUST:

1. Be in possession of a valid driver's license or permit in order to sign up for a course
2. NOT be a Commercial Driver License holder
3. Pay the court costs by money order or cashier's check in the amount of **\$110.00**, which includes a dismissal fee to "Coleman County JP". This \$110.00 cost is payable when you send your certificate of completion within the 90-day period.
4. Complete a driving safety course or motorcycle operator training course as applicable within 90 days of my required appearance date that is shown on my citation.
5. Submit by the 90th day from the required appearance date shown on your citation, the ORIGINAL (no copies, scans or faxes) certificate of course completion of a driving safety course or a verification of course completion of a motorcycle operator training course as evidence that I have completed such a course;

----I UNDERSTAND THAT:

1. **If I comply with the interim judgement granting the taking of a driving safety/motorcycle operator training course and submit all the required evidence as ordered, the Court will dismiss my case and report to the Texas Department of Public Safety the date that I completed my course for inclusion on my driving record;**
2. **If I fail to submit all the evidence required by the Court, I will be notified of a show cause hearing and be required to appear before the Court to show cause why I did not present the required evidence of course completion;**
3. The judge may at the show cause hearing enter a final adjudication against me and require me to pay the fine; and
4. The failure to appear at the show cause hearing will result in a default final judgement being entered against me, and that I will be required to pay the fine and any additional costs required by law.
