and elect under Article 45.0511, Code of Criminal Procedure, to take a driving safety course.

----I UNDERSTAND THAT IN ORDER TO BE ELIGIBLE, I MUST:

- HAVE a valid Texas driver's license or permit in order to sign up for a course (*Active Duty Military-any state*)
() By selecting this, I AFFIRM that I am on Active Duty in the Military (*Title 10 or Title 32*)
- NOT be a Commercial Driver License holder (*CDL – ANY STATE*) (*CDL TX - CLASS A OR B LICENSE*)
- AFFIRM that I have not completed a driving safety course within the last 12 months for ticket dismissal
- NOT be cited by the officer for speeding 95 MPH or more, no matter the posted limit
- NOT be cited by the officer for speeding 25 MPH or more, over the posted limit

----I UNDERSTAND THAT IN ORDER TO COMPLETE ALL REQUIREMENTS, I MUST:

- COMPLETE a driving safety course or motorcycle operator training course as applicable within 90 days of my required appearance date that is shown on my citation.
- SUBMIT by the 90th day from the required appearance date shown on your citation, the ORIGINAL (no copies, scans or faxes) certificate of course completion of a driving safety course or a verification of course completion of a motorcycle operator training course as evidence that I have completed such a course;
- RENDER PAYMENT of the court costs by money order or cashier's check in the amount of \$110.00, which includes a dismissal fee to "Coleman County JP". This \$110.00 cost is payable when you send your certificate of completion within the 90-day period.

----I UNDERSTAND THAT I AM RESPONSIBLE FOR THE FINAL OUTCOME OF MY CASE:

- IF I COMPLY with the interim judgment granting the taking of a driving safety/motorcycle operator training course and submit all the required evidence as ordered, the Court will dismiss my case and report to the Texas Department of Public Safety the date that I completed my course for inclusion on my driving record;
- IF I FAIL to submit all the evidence required by the Court, I will be notified of a show cause hearing and be required to appear before the Court in person to show cause why I did not present the required evidence of course completion; failing this: The judge may at the show cause hearing enter a final adjudication against me and require me to pay the fine; and failure to appear at the show cause hearing will result in a default final judgment being entered against me as a conviction and that I will be required to pay the fine and any additional costs required by law.
