## 2. Presiding Officer.

- a. The CCCSC Presiding Officer serves at the pleasure of the 42<sup>nd</sup> District Judge and is appointed by the same and is a non-voting member, unless in the case of a tie.
- b. The Presiding Officer must attend all CCCSC Meetings.
- c. The Presiding Officer is the undersigned.

### 3. Elected Officials.

- a. This appointment is effective and coincides with the four-year period of the individual's elected term of office.
- b. Upon re-election the individual shall be re-appointed to serve on this committee for another term.
- c. If a non-incumbent becomes elected, then that new individual shall be appointed to serve on this committee as such.

#### 4. Notes.

- a. \*\*Note 1: The term for the County Extension Agent shall be indefinite or until such a time as the individual appointed above retires, resigns or is removed.
- b. \*\*Note 2: Or the term for the County Extension Agent shall serve by appointment so long as the County Extension Agent occupies office space within the four walls of the Coleman County Courthouse.
- c. \*\*Note 3: This Office may send a representative to meetings to make recommendations, participate in discussions, and vote on behalf of the named official appointed herein.
- d. \*\*Note 4: This Official must attend. No representative may attend in his/her stead.
