**APPLICATION TO PROBATE WILL AND
FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

MIRANDA SHEA SHERIDAN ("Applicant"), furnish the following information to the Court in support of this Application for the probate of the Will of SHARON KAY SHERIDAN ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, MIRANDA SHEA SHERIDAN, is an individual interested in this Estate, being domiciled in and residing in Texas. MIRANDA SHEA SHERIDAN's address for service of citation is 3909 Colefax Ln., Norman, Oklahoma. The last three digits of the social security number of MIRANDA SHEA SHERIDAN are 203. The last three digits of the driver's license number of MIRANDA SHEA SHERIDAN are 898.

2. Decedent died on January 30,2023, at a Hospice Facility in Rifle, Garfield County, Colorado, at the age of 79 years. Decedent's domicile at the time of her death was at Santa Anna, Coleman County, Texas, 76878.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$100,000.00.

5. Decedent left a valid Will dated October 23, 2014, which was never revoked.

Decedent left a valid Codicil dated January 12, 2018, which was never revoked. The Will and Codicil will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

6. A necessity exists for the administration of the Estate.

7. 7. No child was born to or adopted by Decedent after the Will was made.

8. No marriage of the Decedent was ever dissolved after the Will was made.

9. Decedent's Will named ROBERT DALE SHERIDAN to serve as Independent Executrix to act without bond or other security. If not ROBERT DALE SHERIDAN then ROBYN SOX to serve as Independent Executor. If not ROBYN SOX then MIRANDA SHE SHERIDAN to serve as Independent Executrix. Decedent's Codicil named ROBERT DALE SHERIDAN to serve as Independent Executrix. If not ROBERT DALE SHERIDAN the MARANDA SHEA SHERIDAN to serve as Independent Executrix. MIRANDA SHEA SHERIDAN resides in Norman, Cleveland County, Oklahoma. MIRANDA SHEA SHERIDAN is not disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such Letters.

10. No state, governmental agency of the state, or charitable organization is named by the Will as a devisee.

11. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are **Theresa Patterson**, and **Everett J. Grindstaff**. The Codicil was made self-proved in the manner prescribed by law and the subscribing witnesses to the Codicil are **Everett J. Grindstaff** and **Jeff Grindstaff**.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to MIRANDA SHEA SHERIDAN; and that all other Orders be entered as the Court may deem proper.
