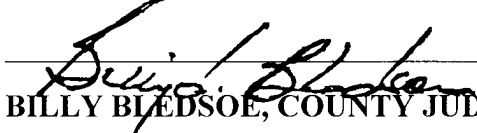

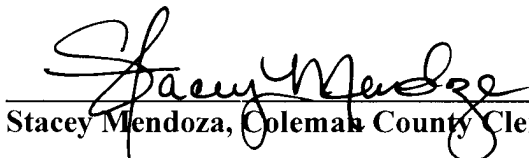
COLEMAN COUNTY COURTHOUSE ACCESSIBILITY STATEMENT FOR DISABLED PERSONS
