**DEFENDANT'S REQUEST FOR A DRIVING SAFETY COURSE**

I hereby enter my appearance on the complaint of the offense of: \_\_\_\_\_ in person, by counsel, by fax, by regular mail, or by email. I understand that I have a right to a jury trial. I hereby waive my right to a jury trial, plead:

- GUILTY or
- NOLO CONTENDERE aka "NO CONTEST"

and elect under Article 45.0511, Code of Criminal Procedure, to take a driving safety course. I have not completed a driver safety course/defensive driving course within the last 12 months for a ticket dismissal.

**----I UNDERSTAND THAT I MUST:**

1. Be in possession of a valid driver's license or permit in order to sign up for a course;
2. NOT be a Commercial Driver License (CDL A or CDL B) holder;
3. NOT be cited by the Officer for speeding 95 MPH or more;
4. NOT be cited by the Officer for speeding 25 MPH or more over the posted limit;
5. Complete a driving safety course or motorcycle operator training course as applicable within 90 days of my required appearance date that is shown on my citation; and, submit by the 90th day from the required appearance date shown on your citation, the ORIGINAL (no copies, scans or faxes) certificate of course completion of a driving safety course or a verification of course completion of a motorcycle operator training course as evidence that I have completed such a course.
6. Pay court costs in the amount of **\$146.00**, which includes a dismissal fee, to "Coleman County JP". This \$146.00 cost is payable when you send your certificate of completion within the 90-day period. **----I UNDERSTAND THAT:**

1. **If I comply with the interim judgement granting the taking of a driving safety/motorcycle operator training course and submit all the required evidence as ordered, the Court will dismiss my case and report to the Texas Department of Public Safety the date that I completed my course for inclusion on my driving record;**
2. If I fail to submit all the evidence required by the Court, I will be notified of a show cause hearing and be required to appear before the Court to show cause why I did not present the required evidence of course completion;
3. The judge may at the show cause hearing enter a final adjudication against me and require me to pay the fine; and
4. The failure to appear at the show cause hearing will result in a default final judgement being entered against me, and that I will be required to pay the fine and any additional costs required by law.
